Subject: Cancellation of CGCI's 2020 Convention

In accordance with Article XI, Sec. 1 in CGCI's bylaws, the CGCI Board of Directors has voted and approved cancellation of the 2020 Annual convention scheduled May 26-30, 2020 in South San Francisco. This difficult decision is made in light of the numerous states of emergency recently declared by federal, state, county and local city officials regarding the worldwide coronavirus (COVID-19) pandemic.

We are grateful to all members who have generously donated both their time and talent to organize this convention. A special 'thank you' to Bay Ocean and Santa Clara Valley District members for their hard work! Stay tuned for future convention announcements.

Guidelines and restrictions from various levels of public health authorities are changing often - for example:

*Large events/mass gatherings are currently limited to 50 people or less for the next eight weeks by the Center for Disease Control to try to avoid the spread of the COVID-19 coronavirus pandemic.

*COVID-19 is especially dangerous for those individuals age 60 and older as well as anyone with underlying health challenges and limits gatherings to ten or less individuals.

*We are learning new vocabulary like "social distancing" – maintaining six feet spacing between individuals.

*The governor has now mandated all California residents to shelter in place by staying home until further notice that many of us have already been doing in Bay Area counties. See https://covid19.ca.gov/ for details.
