FS-9 ALL-HORTICULTURE SHOW (continued)

Requirements:

1. Must conform to the standards established by National Garden Clubs and be registered with the State Flower Show Awards Chairman.
2. Eight basic requirements for a CGCI All Horticulture Flower Show must be met.
 - A. Must be planned and staged by a member club of CGCI.
 - B. All fresh horticulture exhibits must have been grown by exhibitor.
 - C. A printed schedule must be written for the exhibitors and becomes the "law of the show".
 - D. Must include five (5) sections with a minimum of three (3) classes in each section.
 - E. A minimum of one (1) Educational Exhibit conforming to National Garden Clubs standards must be included.
 - F. The Show must be judged by a panel(s) of three (3) NGC judges. Names of the judges must be submitted to the State Flower Show Awards Chairman.
 - G. Must be judged by the Standard System of Awarding. Ribbons or seals may be given by the District or Club. Top Awards should be 95 points or above. However, they cannot be NGC Top Awards, since this is not a Standard Show (they can be called Chairman's Award, Club Award, Section Award, etc.).
 - H. Correct and complete botanical labeling is a requirement for all Top Awards and should be the goal for all entries.
3. Books of Evidence to be sent to the State Flower Show Awards Chairman by January 10.
