## WINTER BOARD GENERAL MEETING

- 4) President Gordon gave his greetings to the Board and made announcements and the health situation of several members. He also gave his State of the State address: *"You can't see both sides of the coin at once"*. He reported on a) Membership, b) Fund-raisers, c) Financial Status, d) State Project and e) *"San Simeon Selebration"*.
- 5) George Speer read the Election Procedures.
- 6) Recording Secretary, Marcha Grant, read the **Executive Committee Recommendations** as follows:
  - Approve an expense of \$2,000 to host a reception for Beverly Brune and Virginia Bennetts at the 2005 Pacific Region Convention. Monies to come from the General Fund. **PASSED.**
  - Approve \$7,500 to be set aside from the Wildflower fund for the President Elect's Project. Elisabeth Tufo to present project. **(Attached) PASSED.**
  - Approve the formation of the *"Circle of Poppies"* which will begin immediately. Elisabeth Tufo to present project. Nominations were Dorothy Copeland, Frances Frenzel and Alice Heileman. **PASSED.**

- Approve: a) the creation of a CGCI Girl Scout Jacket Patch and b) approve that the creation and original purchase of the patches comes from the youth fund and will be gradually reimbursed by patch recipients. **PASSED.**
  - Approve the availability of a 501c(3) tax umbrella for *Group Exemption Status* to be offered to unincorporated Garden Clubs. Maryanne Lucas to present project with George Perko. **PASSED.**
  - Approve the expense of \$345 to produce 1,000 tri-fold butterfly brochures to be distributed to those attending the 2005 Design Tour. This expense would be added to the Design Tour budget. **PASSED.**
- 7) Marilyn Oberti, Chairman of the Nominating Committee, read the slate of nominees to be voted on at Convention 2005. **(Attached)**
- 8) President Gordon discussed the value of meeting the District Legislators & Senators at the 2005 Convention. The arrangement of said meetings (via the CA State Florists Assn) would cost CGCI \$1,000. The vote being so close, it was tabled for a re-vote at the next business meeting where those not eligible to vote would be separated from the board.

# JUBILEE GRANTS PROGRAM

As you know CGCI will observe its 75<sup>th</sup> anniversary in December 2006. To celebrate this event a grants program, the *Jubilee Grants*, similar to the NGC *PETALS* program, is being proposed. \$10,000 will be made available to CGCI clubs, groups of clubs and districts for landscaping projects, which may include Blue Star Memorial Marker and Habitat for Humanity landscaping, incorporating California's native plants and wildflowers. Grants of up to \$1000 may be awarded to applying groups, no matching funds will be required.

To fund this program I am requesting \$7,500 from the Wildflower Fund, which currently holds in excess of \$12,000, a portion of which would be replenished by the Wildflower Conference slated for May 2007. The remaining \$2,500 would come from monies donated to the 2005-2007 CGCI President's Project - a new concept, our members' donations returning to our members! Should more than the required \$2,500 be donated the amount of available grant money would be increased accordingly.

If the *Jubilee Grants Program* is approved it will be in excellent hands! Marilyn Oberti, NGCs co-chair for the *PETALS* project, will administer it with Carolyn Villi, who was CGCI's *PETALS* chairman, chairing the President's Project. Carol Sexton will manage the fund.

At this time your approval is needed for \$7,500 from the Wildflower Fund to be used for the *Jubilee Grants Program 2005-2007*. Pending that the resolution for the President's Project 2005-2007, *Jubilee Grants*, will be read; this will then be re-presented for your approval at the Pre-Convention Board Meeting in Sacramento.

## President's Project Resolution JUBILEE GRANTS

**WHEREAS**, The President's Project, 2005-2007, shall be named Jubilee Grants.

**WHEREAS**, Monies donated to the CGCI Presidents Project 2005-2007, *Jubilee Grants*, shall be added to the \$7,500 from the Wildflower Fund to become the Jubilee Grants Fund.

**WHEREAS**, Monies donated in excess of the \$2,500 required to bring the Jubilee Grants Fund to \$10,000, shall increase the available grant money accordingly.

**WHEREAS**, All monies in the Jubilee Grants Fund shall be disbursed in varying amounts up to \$1,000 by the program's administrators, to CGCI clubs, groups of clubs and districts who have applied for, and been selected to receive, a Jubilee Grant.

**WHEREAS**, Jubilee Grants shall be awarded for landscaping projects, which may include Blue Star Memorial Marker and Habitat for Humanity landscaping, emphasizing California's native plants and wildflowers.

**WHEREAS**, CGCI clubs, groups of clubs and districts shall apply for Jubilee Grants prior to February 1, 2006.

**WHEREAS**, Jubilee Grant recipients shall complete their projects by May 1, 2007.

**WHEREAS**, Jubilee Grant recipients who are unable to fulfill their obligations shall return the monies they received to the Jubilee Grant Fund.

**WHEREAS**, Any and all monies remaining in the Jubilee Grant Fund after May 1, 2007 shall revert to the Wildflower Fund.
