Beverly Switzer, reporting for the Youth Team, moved to ratify these 6 youth groups:

1. Luther Burbank District is sponsoring "The Sierra Youth Center" junior gardeners- which is a RESIDENTIAL facility for troubled teen girls-Joelle Holford is providing hands on guidance to these 15 girls.
2. The Diablo View Student Garden Project is made up of 25 physically or mentally challenged young people-Clayton Valley Garden Club is sponsoring this group.
3. In the Roadrunner District-the Desert Crossroads Garden Club is sponsoring 85 FFA (Future Farmers of America) students at this Lucerne Valley High School. Linda Riddle will be working with this group.

Chuck Goodwin moved to include his full IRS Nonprofit Group Exemption and Legislation/Government reports in the minutes. **PASSED** (See Attachment G)

ANNOUNCEMENTS

President Lucas announced that a committee including Chuck Goodwin and Julie West Was appointed to review the Slosson fund and frame another response to Mr. Dooley. Elisabeth Tufo volunteered to serve on the committee and was appointed.

Jane McKee reported that Palomar District's bank (Wells Fargo) advised that all banks are starting to enforce that the pay to line on business accounts must exactly match the name on the account.

BYLAWS & POLICY

George Speer moved to consider all bylaws changes in their entirety. **DEFEATED**

On behalf of the committee, Julie West moved to submit the following bylaws amendments to the voting membership at convention:

1. **ARTICLE IV - MEMBERSHIP AND DUES** (page 128)

Sec. 1. The membership of this corporation shall consist of 5 classes: garden clubs, associate plant societies, affiliates, life members and all categories of youth gardeners. Voting memberships shall be garden clubs **and** associate plant societies **and affiliates**. Nonvoting memberships shall be all categories of youth gardeners, **affiliates** and life members.

Rationale: Some clubs appear to be looking for ways to avoid belonging to districts and paying district dues by becoming affiliates. Moving affiliates to nonvoting membership removes one incentive to change.

PASSED

2. ARTICLE IV - MEMBERSHIP AND DUES (page 128)

Sec. 3. All dues are payable on July 1 and delinquent on ~~November~~ **October** 1. Dues shall be payable to CGCI and mailed to the membership chairman who shall transfer the funds promptly to the treasurer. **(a)** Garden Clubs and Associate Plant Societies shall pay annual dues of two dollars twenty-five cents (\$2.25) per capita which shall include dues to NGC, effective July 1, 2008. **(b)** The per capita dues of any new club or associate plant society shall accompany application for membership. Clubs or associate plant societies shall forward dues on a quarterly basis for new members accepted during the previous quarter to the membership chairman. **(c)** Affiliates shall pay annual dues of fifty dollars (\$50.00) regardless of size. **(d)** New clubs **and** associate plant societies **and affiliates** joining CGCI between January 1 and June 30. ~~which are due July 1 and delinquent November 1.~~ They shall be ratified at the winter board meeting or the pre-convention meeting and shall be entitled to representation at the convention. **(e)** If dues are not paid by ~~November~~ **October** 1, clubs and associate plant societies become ineligible for CGCI liability insurance and participation in the CGCI awards program. **In addition, clubs also become ineligible for the CGCI 501(c)(3) IRS Group Exemption.** **(f)** All categories of youth gardeners shall pay no dues to CGCI. Membership dues to NGC, including dues for youth gardeners, and dues to Pacific Region shall be paid annually from the general fund. **(g)** Life memberships are honorary and require a onetime contribution of one hundred dollars (\$100.00). Life membership contributions after June 1, 1997 will not include *Golden Gardens*. A club or associate plant society shall pay state dues for all members, including life members.

Rationale: Changing the date to October 1 shortens window to 90 days past date of July 1 when dues become delinquent. Still allows plenty of time for clubs to remit their dues. Liability insurance bills are typically mailed at end of October or first of November so no overlap of delinquent dues vs. eligibility for liability insurance will occur as it does today.

Also, removes affiliates from paying one-half the annual dues (\$50) if they join CGCI between January 1 and June 30. \$50 dues is membership fee regardless of when they join.

In addition, need to make it clear that if a club fails to remit dues on time, the club is not eligible to participate or continue participating in CGCI's 501(c)(3) IRS Group Exemption program.

PASSED

3. ARTICLE V - OFFICERS AND THEIR DUTIES (page 129)

Sec. 2 (c) appoint the parliamentarian, all chairmen of standing and special committees ~~(~~except the nominating committee, board of trustees, **advisory council, budget and finance**), and fill vacancies on the board of trustees.

Rationale: Article XV states the immediate past president shall act as chairman of the Advisory Council and Article XII Sec. 6 (a) states the financial secretary shall serve as the chairman so they are not appointed by the President and need to be added as exceptions.

PASSED

4. ARTICLE VI – NOMINATIONS AND ELECTIONS (page 130)

Sec. 2 d (3). At the Fall Board Meeting, in odd-numbered years, the committee shall notify all board members of offices to be filled, such notice to be published in ~~the following issue of~~ *Golden Gardens*.

Rationale: Depending on the publication schedule of *Golden Gardens*, the notice could possibly be published in the "summer" issue since all offices, except that of President, are in fact "open."

PASSED

5. ARTICLE IX - DISTRICTS AND DISTRICT DIRECTORS page 132)

Sec. 6. Board meeting chairmen may be appointed by the president upon recommendation from the host district following selection of the Board meeting locale. (new Sec. 6 with renumbering of remaining sections.)

Rationale: This wording is similar to Article XI – Annual Meetings. Sec. 8. The President needs to be able to work with the Board Meeting Chairmen and have him/her ratified which is the same process for Convention chairmen. Eliminates inconsistencies of sometimes ratifying a board chairman and sometimes not.

PASSED

6. **ARTICLE X – CHAIRMEN AND COMMITTEES** (page 133)

Sec. 1 There shall be such standing committees as are necessary for the operation of the corporation. The president shall appoint chairmen subject to ratification by the board of directors.

Sec. 2 Special committees shall be appointed as needed subject to ratification by the board of directors.

Strike and replace with:

Sec. 1 There shall be such standing and special committees as are deemed necessary for the operation of the corporation. The president shall appoint chairmen (except the nominating committee, board of trustees, advisory council, budget and finance), subject to ratification by the board of directors.

Rationale: Combines two sections into one and notes those chairmen the President does not appoint as provided for elsewhere in the bylaws (Article VI Sec. 2 (d) 2; Article XIV Sec. 2; Article XV and Article XII Sec. 6).

PASSED

7. **ARTICLE XII – FINANCES** (page 134)

Sec. 5. Net proceeds from conventions shall be placed in the General Fund. **Half of the net proceeds from conventions shall be placed in the General Fund and the remaining half shall be retained by the Host District(s) or Host Club(s).**

Rationale: Change specifies distribution of proceeds from conventions. This was proposed previously. It was tabled and a special committee was formed; however no recommendation was made or report provided by that committee.

Robin Pokorski moved to **refer back to the committee. PASSED**

8. **ARTICLE XII – FINANCES** (page 134)

Sec. 6. The finance and budget committee shall: (a) **include** consist of the financial secretary, who shall serve as the chairman, first vice-president, treasurer, chairman of the board of trustees, and **one person up to three members** who shall be appointed by the president, (b)...

Rationale: By allowing the President to appoint additional people to serve on the Budget & Finance Committee, some or all of the vice presidents may be included so as to become familiar with CGCI's finances, various members of the Board of Trustees, as well as members from the assembly at large.

PASSED AS AMENDED

9. **ARTICLE XII – FINANCES** (page 134)

Sec. 7. The following are budgeted from the General Fund: (a) president's reimbursement of up to ~~\$5,000~~ **\$10,000.00** annually for verified expenses incurred for state travel and office expenses including mileage reimbursement in accordance with the current IRS business mileage rate, (b) president's reimbursement ~~of up to \$5,000.00 annually~~ for verified expenses incurred in attending two meetings of NGC and one Pacific Region meeting, (c) president-elect's reimbursement of up to \$1,500 for verified expenses incurred in attending one meeting of NGC, and (d) a reimbursement of up to \$1,500 annually for verified expenses when the Pacific Region director is from California.

PASSED AS AMENDED

10. **ARTICLE XII – FINANCES** (page 134)

Sec. 10. ~~The financial secretary, treasurer, liability insurance chairman and Golden Gardens finance chairman shall be bonded in equal amounts.~~ **A crime policy that includes Employee Dishonesty coverage** Bonds to **will** be furnished by CGCI **and paid from the General Fund.**

Rationale: CGCI has not had a fidelity bond for named positions in several years. The current coverage is provided by a crime policy with blanket Employee Dishonesty coverage and is not restricted to those four chairmanships.

PASSED

11. **ARTICLE XIV - BOARD OF TRUSTEES** (page 135)

Sec. 2. Immediately following the post-convention meeting in an odd-numbered election year and immediately following the pre-convention meeting in an even-numbered, non-election year, the president shall call a meeting of the board of

trustees to elect a chairman and secretary who shall serve for one year and may be reelected for ~~an~~ **one** additional **one-year** term. Four members shall constitute a quorum. If the chairman is unable to represent the trustees at board meetings, the secretary may act as alternate. The board of trustees shall meet upon call of the chairman, or secretary acting in absence of the chairman.

Rationale: Clarifies the original intent of a one-year term followed by one additional one-year term as the maximum time served as Chairman and Secretary.

PASSED

***Golden Gardens* Editor Proposed Bylaw Amendments**

PROVISO: All bylaw amendments relating to the *Golden Gardens* Editor including Article V Sec. 1; Article V Sec. 8; Article VI Sec. 1 b(3); Article VII Sec. 1; Article VIII Sec. 1; Article XIII Sec. 1; Article XIII Sec. 3 and Article XIII Sec. 5 shall take effect at the close of the CGCI Convention May 18, 2011. **NOTE:** If the amendment to Article V Sec. 1 (Item #12) were to fail, the remaining proposed bylaws amendments as respects *Golden Gardens* Editor will not be presented for consideration.

On behalf of the committee, Julie West moved to submit the following bylaws amendments to the voting membership at convention:

12. ARTICLE V - OFFICERS AND THEIR DUTIES (page 129)

Sec. 1. **(a)** Elected officers shall be president, first vice-president, second vice-president, third vice-president, recording secretary, corresponding secretary, financial secretary **and** treasurer ~~and *Golden Gardens* editor~~. **(b)** The appointed officer shall be the parliamentarian.

Rationale: Subscriptions for *Golden Gardens* have declined to approximately 3,700 subscribers of which CGCI purchases 375 complimentary subscriptions for club presidents, APS presidents, affiliate presidents and district directors. In addition, individuals who became life members before June 1, 1997 receive subscriptions paid by CGCI. Position does not appear to warrant inclusion on the Executive Committee and could be handled by making the position a Standing Committee Chairmanship under Article VII – Board of Directors.

PASSED

Jane McKee moved that the seven following proposed amendments be treated as a whole. **PASSED**

On behalf of the committee, Julie West moved to submit these seven bylaws amendments (#s 13-19) to the voting membership at convention. **PASSED**

13. ARTICLE V - OFFICERS AND THEIR DUTIES (page 129)

~~Sec. 8. The *Golden Gardens* editor shall supervise publication of *Golden Gardens*.~~
Move this to Article XIII – *Golden Gardens* and renumber #9 to #8.

14. ARTICLE VI – NOMINATIONS AND ELECTIONS (page 130)

Sec. 1 b (3). The **treasurer**, recording, corresponding and financial secretaries, ~~treasurer and *Golden Gardens* editor~~ only shall be eligible for two two-year terms. No officer shall serve longer than four years in any one position except that eligibility restrictions shall not apply to the appointive office of parliamentarian.

Rationale: Removes *Golden Gardens* editor as being limited to two terms since position no longer subject to election.

15. ARTICLE VII - BOARD OF DIRECTORS (page 131)

Sec. 1. Composition of the CGCI board of directors shall be: **(a)** officers, **(b)** district directors, **(c)** members of the nominating committee, **(d)** members of the board of trustees, **(e)** members of the advisory council, **(f)** members of the bylaws committee, **(g)** members of the Circle of Poppies, **(h) editor and members of the *Golden Gardens* committee and (i) all committee chairmen**. One-third shall constitute a quorum. No member shall be entitled to more than one vote.

Rationale: Adds editor and members of the *Golden Gardens* committee to be members of the board of directors under Article VII and clarifies all committee chairmen (including both standing and special committees) are members of the board of directors.

16. **ARTICLE VIII - EXECUTIVE COMMITTEE** (page 132)

Sec. 1. Executive committee of the board of directors shall consist of the president, vice-presidents, recording, corresponding and financial secretaries, treasurer, ~~Golden Gardens editor~~ and parliamentarian. A majority shall constitute a quorum.

Rationale: Position does not appear to warrant inclusion on the Executive Committee and could be handled by making the position a Standing Committee Chairmanship under Article VII – Board of Directors.

17. **ARTICLE XIII - GOLDEN GARDENS** (page 135)

Sec. 1 ~~CGCI shall publish an official magazine, Golden Gardens.~~
Strike and replace with:

Sec. 1 The official publication of CGCI shall be Golden Gardens, electronic or print.

Rationale: Allows flexibility for future of *Golden Gardens*.

18. **ARTICLE XIII – GOLDEN GARDENS** (page 135)

Sec. 3. **The Golden Gardens editor shall (a) supervise publication of Golden Gardens, (b) keep the cost of publication within the budget adopted by the board of directors. Any additional expenditures shall be presented to the executive committee for approval prior to incurring indebtedness, (c) be chairman of the Golden Gardens Committee and (d) report to the board of directors at all board meetings and conventions. (re-number remaining sections)**

Rationale: Incorporates Sec. 8 from Article V, defines the editor's role and requires the reporting necessary as a permanent Standing Committee of the Board of Directors.

19. **ARTICLE XIII – GOLDEN GARDENS** (page 135)

Sec. 5. Changes in advertising rates shall be recommended by the editor **to the executive committee** and ratified by the board of directors.

Rationale: Establishes communication from editor to Executive Committee to board of directors.

On behalf of the committee, Julie West moved to amend the following Standing Rules:

~~70. Membership chairman shall send, by July 1, copies of the current (June 1) district rosters and a list of associate plant societies to the following: corresponding secretary, yearbook chairman, Golden Gardens circulation chairman, liability insurance chairman and youth activities chairman. (pages 140-141)~~

Strike and Replace with:

70. Membership chairman shall send, by July 1, a list of all clubs, associate plant societies and affiliates with names, addresses, telephone numbers and email addresses of the presidents, treasurers and youth gardener leaders to the CGCI President, Vice Presidents, Corresponding Secretary, Yearbook Chairman, Golden Gardens Circulation Chairman, Liability Insurance Chairman, Website Chairman and Youth Activities Chairman. The list should follow the format of the state roster.

Rationale: Rosters need to be routed to the website chairman for posting with courtesy copies provided to the President and Vice Presidents and is customary practice today. In addition, this reinforces Article IX Sec. 6 in the bylaws, utilizing the same description of what the "list" is to include that is to be distributed by the CGCI Membership Chairman.

PASSED

~~74. An associate plant society shall (1) be a member of a permanent statewide or national plant society, (2) be entitled to representation at annual meeting by its president or alternate, and delegates as specified in Article XI, Section 5. (3) pay annual dues according to Article IV, Sec. 3(a), (4) not belong to a district, and (4) be eligible to apply for liability insurance and (5) not be eligible to apply for 501(c)(3) IRS Group Exemption Program. In addition, an associate plant society may also belong to a district. (page 141)~~

Rationale: Clarifies that associate plant societies are not eligible to participate in CGCI's 501(c)(3) IRS Group Exemption program because they are members of permanent statewide or national plant societies.

PASSED

76. A club shall pay CGCI annual per capita dues, belong to a district **and be eligible to apply for** CGCI liability insurance **and 501(c)(3) IRS Group Exemption Program**. ~~An associate plant society, which chooses to belong to a district, shall be classified as a club.~~ (page 141)

Rationale: Clarifies that only qualifying clubs are eligible to apply for liability insurance and CGCI's 501(c)(3) IRS Group Exemption program.

This officer recently happened across reports from 9 years ago when Robin was Recording Secretary. We were still printing and mailing minutes to all board members then at a cost of \$113.40 for copying and \$135.60 for postage to distribute the 2001 Winter Board Meeting minutes.

Changing to email distribution is saving CGCI a lot of money. I have had to mail minutes to only 20 board members who do not have email. If any of you receiving minutes by snail mail obtain email access please let me know. In addition to emailing state meeting minutes to board members, I hope all of you are aware that our minutes are posted on our website – in the Board Member area.

Thanks to all who have responded to the information about report submission that was provided in the October email distribution of our Fall Board Meeting minutes and in the recent e-newsletter. At this point more reports have already been submitted for this Winter Board Meeting than were submitted for Fall Board Meeting.

Regardless of the length of reports you present orally or submit in writing to the President and to the *Golden Gardens* Editor, please submit short form reports – the guideline is 100 words – this is no more than two inches of text – to the Recording Secretary.

Julie West will be providing some additional information on this subject, but if you want your report attached to our minutes please submit it to this Recording Secretary by 1/17/2010, one week from tomorrow, and submit by email if at all possible. Thank you.

3rd Vice President, Rita Desilets Membership Chairman's Report

As of January 5, 2010, there were **276 clubs** with **15,639** members; **55 associate plant societies** with **3,866** members, resulting in a total membership of **19,505**. **23 affiliates** have paid dues. This year dues bills will be mailed shortly after the June Convention, rather than mid-May.

Last summer, this chairman sent letters to about 60 arboreta and botanic gardens, inviting them to become part of our new Participating Arboreta/Botanic Garden Program. Recently two more Botanic Gardens have been added to the original nine: Chico University Arboretum and Earl Burns Miller Japanese Garden at California State University, Long Beach Your membership card entitles you to any or all of the following: free admission, 10% discounts at gift shops or plant sales. Many of the gardens not responding were sent a second letter containing an invitation to become a CGCI Affiliate.

This chairman has written a second gardening pamphlet, "Edible Landscaping" which, along with "Conservation Gardening" is available on the website. A copy is posted on the display board at the Membership Table.

CGCI banners are still very popular! The newly developed Banner Order form, available on the CGCI Website, simplified the ordering process. For a limited time a free banner bag will be given to clubs or districts ordering both the stand and banner. Several stands have been brought for orders taken at this meeting.

CGCI promotional materials such as the rack cards, bookmarks, posters and the new CGCI brochure have been counted, bundled and are ready for pick up at the Membership table. Be sure to remind those who take these materials to put their club information in the space provide before using.

This fall, your Membership Chairman did an internet search for any Plant Society or garden club not belonging to CGCI. Over 260 packets containing a cover letter, membership application and list of benefits of membership were mailed. A

similar packet will be put in each District Directors file and some are found at the Membership table. If you come across a potential candidate and don't have a packet to give them, please send me their contact information and a copy of the new "Invitation to Membership" packet will be sent to them.

The Membership theme for the 2009-2011 is "*One by One*". This chairman's article published in the Aug/Sept *Golden Gardens* introduced the theme. A second article in the Oct/Nov issue of *Golden Gardens* listed five ways to publicize your club and CGCI. An entire page listing the Benefits of Membership was included in the Dec/Jan issue. Look for an article in the Feb/Mar issue containing ideas for making visitors feel so welcome they will want to join your club.

eNewsletter

The electronic newsletter was launched in November. So far, three issues have been sent. Initially all club, affiliate and APS presidents, district directors, chairmen and Executive Committee Members were automatically included in the subscriber list. Whenever changes are made or new presidents join, this chairman automatically makes the changes and signs-up the new presidents. It is up to the individual club members to sign up for the eNewsletters on the CGCI website. As of today, there are over 600 subscribers. CGCI is hopeful to eventually have all of our club members with email capabilities as subscribers. Flyers have been placed in the district directors' folders with exact directions for sign-up which they should give to each club president for their members. The newsletter will be sent whenever there is enough information or an immediate need to send it – possibly once a month. This is CGCI's 21st Century way of communicating with our members without creating spam or wasting trees or spending money on postage. It is also a link with the website and *Golden Gardens*, and all of NGC's and Pacific Region's websites and publications. [Currently, the cost is \$15.20 per month for 1,000 subscribers with the capability of sending six eNewsletters per month. The next level is for 2,500 subscribers at \$23.20 per month.]

Since its activation in August, this chairman estimates that 1-3 calls per month were received from prospective members. A few calls per month were received from garden club members with questions; this chairman evaluated the calls and forwarded them to the appropriate chairman for response. [The plan is \$43.79 per month, but with all of the taxes, the cost comes to \$53.50.]

Brochures/Pamphlets

With the help of Julie West and Rita Desilets and the schools chairmen (Shane Looer, Dolores Moffat, Greg Pokorski and Alexis Slafer), the *Back to School* pamphlet is now finished. The pamphlet has been placed on the website for

download and copies placed in the district directors' box. Also, this chairman is also in the process of preparing pamphlets on *Beginning Creative Design* and *A Flower Arranger's Garden*. Hopefully these will be completed by convention. Finally, this Communications Chairman is hopeful that other chairmen and teams (especially the Horticulture and Conservation Teams) will work with me to develop more educational pamphlets for our members and the public. These pamphlets are great membership assets.

Yearbook

The yearbook continues to be updated. This chairman will easily be able to update it over the summer for the next term. Handouts of corrections have been put into the district directors' box and placed on the table near the door for the chairman. Unfortunately, there are no extra copies left, but pdf files may be transmitted to anyone who needs an extra copy – just let me know.

Awards Coordinator

Last fall, a step-by-step memorandum was created by this chairman and distributed to all award judges. With the memorandum, color coded judging report forms (in triplicate) were included for the judges to report their findings to the Award Chairman, Awards Secretary and Awards Coordinator. Credit for this wonderful new system goes to Julie West. So far, the new system is working! The first batch of awards was judged prior to December 25. The last batch is to be judged by January 31. This will give the Awards Team a lot of time to start planning for the Awards Banquet at Convention.

Fall Board, September 2010

With an overwhelming majority of the Palms to Pines clubs, an invitation was given to CGCI to hold its 2010 Fall Board Meeting in Palm Springs; the draft budget and schedule has been created; six hotels were interviewed (4 in the Palm Springs area, 1 in Riverside and 1 in Lake Arrowhead). The newly renovated and totally modern Hyatt in Palm Springs was the best choice. And now the contract has been signed and the deposit sent. **So, it's official.** The official dates for the CGCI 2010 Fall Board Meeting will be Wednesday, September 15 through Friday, September 17, 2010 with the Palms to Pines District as the host and Pat Clayes as the chairman. More information will be given at convention, but, so far this chairman has planned for a tour of The Living Desert and my team is working on the educational workshops, speakers, programs and possibly entertainment. This will meeting will not only be fun, it will be a very educational and hopefully somewhat affordable event.

It indeed a pleasure and an honor to have the opportunity to represent CGCI at special events like Blue Star dedications, Club celebrations and district meetings.

Having the privilege to talk with members, meet new people, be introduced to exciting places and projects, to learn about the things that are going on around our state and what people are doing is a remarkable experience.

I have been most impressed with the number of years, the amount of time and the sincere dedication that so many of our members have devoted to the things that CGCI's mission include: Things like
Creating interest in gardening, floral design, animal & plant life.
Preserving natural beauty and resources
Spreading knowledge and experience.

The thorough enjoyment of the experience, is balanced however, by a curse with which I have been afflicted since birth. (my mother referred to it as my "burden")

It is what some call a "critical eye"...I prefer "discerning" eye.

An innate need exists to examine what is good and try to make it better. To figure out why things work.... And extrapolate the findings.

- Why does it work like this?
- Has it always worked like this?
- How long will it be able to continue to work?
- Can it be made to work better?

So, as president of California Garden Clubs, when I travel this state and see what is going on...along with me comes that "discerning eye." And what do I see? I am seeing fundamental changes in our society that are having a great impact on our organization. I see that our membership is aging. I see that we are more distracted than we once were. The pressures of aging, of a bad economy, and of the confusing barrage of messages hitting us day in and day out are all taking a toll.

Our country seems to have swung from what could be described as a largely a civic-minded, service-oriented orientation to one that is more socially-oriented while at the same time being self-focused and isolated. These days, a great number of people tend to know more about far-away places and absolute strangers than they do of their own communities and neighbors. While enormous numbers of people spend huge amounts of time on social networks such as FaceBook and Twitter, their actual interaction is, in most cases, reduced to abbreviated text message.

- While social...they are not joining groups.
- While concerned about the state of things, they do not seem to be taking action to affect change.

Yet, I am happy to report that they ARE INTERESTED....THEY ARE CONCERNED....about the very things that occupy the time and talent of CGCI.

Yet our membership is not growing. There is a case to be made that in these times of growing population, because we have remained constant means we have actually declined. Well...We may have declined in numbers, but we are still on top in spirit!

From personal experience, the things I see when working with families at Kids Growing Strong events and in talking to the public at other venues around the state....I can assure you that a great many people ARE very interested in the things that CGCI concerns itself with day in and day out.

So why aren't they joining? When we tell them our mission statement ("California Garden Clubs, Inc. promotes gardening, floral design, civic beautification, environmental responsibility and the exchange of information and ideas.") the response is....well nothing. I get a look like "Yeah...so what?" But whenever I share something with someone – something I am doing or something I have grown – the response invariably is "OH....I want to do that!!!!"

We have a product the public wants. It is in our delivery where we may be slipping. Elisabeth's theme was "Share the pleasures of gardening." That notion is a good first step. It is now time to "Share the pleasures and benefits of garden clubs."

Speaking of product.....

There have been statements made that CGCI should be run as a business. We are not a business. And even if we were, we would be a pretty impoverished one. Our unrestricted assets would not buy us much in California. Our earned income puts us in the food stamp line. And what happens to non-profits when they are run like a business? They often lose their heart. They hire employees, the employees hire staff and the primary goal too-often becomes job preservation.....much like what has happened with our government.

We will do better than that. WE will keep our heart. We will continue to strive to fulfill our mission and objects.....But we may have to be a little more flexible and creative in the way we go about it. You have all heard the arguments about the "old guard" and the "new people." We need not elaborate on that here...except to say there is no right and there is no wrong. Today is different than yesterday. Tomorrow will be different from today. We need to preserve the "essence" of what garden clubs have always been...Friendship, learning, helping, creating, making better, preserving, supporting, respecting....These "products" are eternal. All we need to reshape is the vehicle to deliver these precious assets into a product that will attract and will be carried on by hoards of future members.

Our challenge is to find that path to that end. I do not believe that anyone in this room knows exactly how we should do this. But I am sure that together we will figure it out. We will search and try new things. Some will work, some won't. What is important is that we continue to enjoy the journey – that we keep tryingand that we journey together. Have you ever noticed that a single tree alone in a field does not in general grow especially tall? The single tree has all the light it needs. It will often grow wide and spread its branches, but it doesn't usually get too tall. On the other hand, a tree in a forest that is surrounded by other trees must reach for the light. It constantly grows to become the tallest tree and get more light. When it does become the tallest the other trees strive to catch up and grow toward the light and warmth of the sunlight.

People are a lot like trees. Teams who work closely together provide encouragement and support for each other. By striving to reach the same goals, they grow to great heights together. Please continue to work with us, be open to try new things, be proud if they work and take it in stride if they do not. Use your creativity to think of new ideas, DO not hesitate to remind usGently....of good things we may have forgotten. But above all, stick with us...and bring in people of like-minded spirit. Together, we will reach great heights, too.

Bay Bridges District, Gerry Mellen

Our District has gone through some difficult times; we lost 2 clubs in the last year primarily due to the age of the members. We have cut the number of meetings to twice a year and by not having fundraisers, at least for a few years, we have been able to hold the District together and we are surviving.

At our September meeting we pass out all the information collected from State Meeting. We have passed out a short Parliamentary Procedure packet as well as one suggesting proper procedures for a Nominating Committee, which we hoped would assist new Presidents. In April we distribute the District Awards to our clubs and we award 2 Scholarship Awards to students attending a college and majoring in horticulture and/or related subjects. We allow smaller clubs to donate to the District Fund, thereby allowing them to contribute to the scholarship process.

Bay Ocean District, Nancy McDougal

As size, meeting times & activities of Bay Ocean District clubs vary, so do the activities. Two clubs have annual garden tours—one of its neighborhood & the other of estate gardens. There are garage sales, luncheons & fair entries for fundraising. Community outreach includes floral decorations for healthcare facilities & community buildings and care of a historical garden. This year we are also assembling a list of local speakers & tour sites to assist clubs in obtaining interesting programs for meetings. Each club focuses on the aspects of gardening which most interest their members, bringing variety to our efforts.

Cascade District, Anne Capes

Cascade District has added one youth group and two more are in the active planning stage. In September 2009, two awards were presented by the CGCI Landscape Design Council for gardens that showcased “good land use.” Two new Blue Star Memorial Markers were dedicated recently with 1st Vice President Julie West attending the dedications in impressive ceremonies. Co-chairs Jean Reiley and Beverly Brune and District members are organizing the 2010 CGCI Convention to be held at the Westlake Village Hyatt Hotel, June 4 – 7.

Costa Verde District, Ruth Brooker

Our theme is "Go Green: Conserve Water and Resources." Costa Verde District is making strides in this area with small steps; we hope to make a difference in our environment. The District clubs are having programs and activities to make us aware of how to cut back on waste by recycling things we call trash. We are trying to learn to use water more wisely and to become familiar with drought resistant plants. As District Director, I'm excited about the enthusiasm of our Presidents at our board meetings, with discussion of common goals and their interest in the broader picture of garden club work.

Golden Foothills District, Sue Bennett

Our district has 620 members in 123 clubs. Lake of the Sky GC gave \$2,000 in scholarships to three students, as well as \$5,000 in grants for community gardening projects. They held their 21st annual garden tour at Incline Village which was their biggest ever – selling all 575 tickets and made \$11,070. Colfax GC had their annual Garden Tour, Divide GC had their Annual Fall Plant Sale, Auburn Arrangers had a small Standard Flower Show entitled, "Tea in the Garden," Donner GC held their 54th Chrysanthemum Sale and Chicago Park GC held their 6th Annual Victorian Tea. In addition, the district hosted the Gardening Study School, Course I in September with Course II scheduled for April.

Men's Garden Club of Santa Rosa earned over \$10,000 for their scholarship fund from plant sale proceeds and monetary award winnings for their County Fair display.

Santa Rosa Garden Club held the dedication of the permanent Habitat Sign at the Sonoma State University Butterfly Garden.

Montana de Oro District, Nancy Johnson

Multiflora started with a program about the history of the club and followed this with such activities as "Gardening in Small Spaces," Winery Sustainability," and planning and planting for their spring plant sale. Horticulture Team, Jim Bathgate

There are currently two major pest problems in the Southern Counties--Medfly, which attacks the fruit of many commercial crops and the second pest is the Asian Citrus Psyllid.

The Medfly has some 260 host fruit. During a quarantine maturing fruit is subject to strict controls. In order for a quarantine to be lifted treatment must be employed such as baits, sprays or many sterile male flies released. When no fertile flies are found for the specified life cycles, the quarantine ends. Often the fruit is too mature to market.

Direct damage from the Psyllid is minor but the indirect damage occurs when the Psyllid carries Huanglongbing which is extremely serious.

Landscape Design Study Program, Alexis Slafer

There are no Landscape Design Study Courses currently planned; but preliminary discussions are underway for one in Southern California. Please encourage your clubs and districts to sponsor the next school. Look for handouts about the Landscape Design Study Program in your mailbox. As Chair for the June Landscape Design Refresher planned for the June Convention has been expanded to a Tri-refresher, for consultants in Landscape Design, Gardening & Environmental Studies. All activities will be open to all Convention attendees. Look for more information in the near future.

Liability Insurance, Gloria Aminian

Many clubs and societies have sent in for coverage for the new insurance year. Many have questioned the stated costs. The rate per member is \$1.00. It is not a misprint. The minimum fee for a club/society is \$25. An Additional Insured Certificate is \$20 per location. All meetings/events held at one location can be listed on one Certificate as long as they occur between February 15, 2010 - February 15, 2011. There are a few days left before the Insurance fees are to be paid without incurring any late fees. ... they must be postmarked on or before January 15th.

Life Membership, Carlotta Wixon

This chairman's goal is to exceed the number of last year's new Life Members which was 34. A Certificate of Achievement will be awarded to each district that brings in at least two new members during this term. Last year twelve districts met or exceeded this goal. On November 12, I e-mailed the district directors to remind them of the Nov. 30 deadline. As of November 30 I have received only 16 completed forms. I have compiled the information in two formats- according to district and according to subject.

Propagation "Free Plants," Lee Bathgate

Winter is the best time for propagating hardwood cuttings. There are taken from the previous season's growth where it connects to two-year-old wood. Pomegranates, figs, grapes, olives, some ornamentals and narrow-leafed evergreens are among the plants that propagate well in winter. Make cuttings 5-12" long, cut straight across the bottom, just below a bud and an inch above a bud on top. Make sure the wood has a "green ring" under the bark indicating health and vigor. Use deep containers with a soil mix of 50/50 peat and perlite, sand or mix of sand and peat. Dip cutting tips in rooting hormone and insert into planting mix leaving at least 1-2" with buds above the surface. When new growth appears and roots have developed, pot them individually and grow until large enough to plant out.

Roses, Jolene Adams

Roses originated millions of year ago in a northern temperate zone that included significant winter chill hours. In California we fool the bush into believing that a winter is coming and it needs to shut down:

Late Fall - stop 'deadheading' and just pull off the dying petals and leave the seed pod (the hip) to develop on the stem.

Early Winter - spray the rose bush with an oily, sulfur-based dormant spray. Coat the canes and let the leaves drop off.

Just About Spring - prune the bush. Take about 1/3 to 1/2 off the top. Cut out dead or dying stems. Save about 5 or 6 new stems and cut off the rest of the old ones. Trim to make a vase-shaped bush out of the rose.

Clean up the flower bed and spray the bush one more time with the dormant spray, coating it heavily. Roses will bloom again in Spring, on fresh, new, clean stems.

Scholarships, Evelyn Broaddus

The CGCI Scholarship Committee met on Thursday, January 7th from 3:00 p.m. to 6:00 p.m. Those present were Chairman, Robert Gordon, Virginia Bennett, Beverly Brune, George Perko, Elisabeth Tufo, David West and Evelyn Broaddus, Scholarship Chairman.

The committee conferred, noted and selected two recipients and an alternate for the Immediate Past President Award. The 2010 CGCI Robert L. Gordon Annual Scholarship Recipient is Margaret Maratsos from Cal Poly SLO. She is enrolled in Environmental Horticulture in the School of Agriculture.

The 2010 Immediate Past President Robin Pokorski Scholarship will be awarded to Michael Dunn of Fortuna, California who is enrolled in Agricultural Plant Science with a minor in Environmental Science at the College of the Redwoods. (NOTE: Michael Dunn must be enrolled as a junior in a four year college or university to receive the award.)

The committee selected an Alternate for the Immediate Past President Award. The Alternate selected is Jessica Corcoran, who is a Horticulture and Crop Science major at Cal Poly, SLO.

Sempervirens Fund, Rosa Radicchi

The fires surrounding the Big Basin State Park areas have finally subsided, however, the financial pressures and dangers of park closures throughout the State continue to mount. Since Fall Board Meeting, we have begun the new process of members and clubs sending donations directly to Sempervirens Fund and contacting this chairman by phone or email when the donation has been made. Donations for 2009 were \$645.00; with 13 clubs participating. Total amount towards Grove #10 as of December 31, 2009 is \$6,980. Thank you again for your ongoing support of one of our oldest park conservation efforts ~ Preserving our Redwood Forests.

Water Conservation in Home & Garden, Carole Lung

This Chair submitted an article on the cooperation between the environmentalists and the companies that has allocated contacts for water in the central valley. During the several weeks salmon were running, the companies agree to reduce the amount of water in order for the fish to run to their mating grounds.

As Gardeners we need to look at water from the perspective of our goals as NGC members. We need to have the micro (what we do locally). Our water district give us information on types of plants to plant, how to water, when to water. We are encouraged to reduce water use in our homes through installation of water flow devices, upgrades for our appliances, etc. We need to take personal action in this area.

Then there is the macro (what we support on a global basis). We need to know what is happening to water in the delta and the central valley. We need to support cooperation so all are blessed. Then there is the ocean. And the northern pacific tropical gyre, to see the impact plastic is having on the ocean watch this video from YouTube.

IRS Nonprofit Group Exemption

The CGCI IRS Nonprofit Group Exemption renewal process for member Clubs has begun. Forms have been mailed to exempt clubs. For clubs to retain their nonprofit status, these forms must be returned by February 1, 2010, with a processing fee of \$15. Clubs who have not received the mailing, either from CGCI or forwarded from their previous officers should contact this Chairman.

For other clubs interested in the Group Exemption program, information is available on the CGCI website under the Club Service tab or the Club Support box.

An easy way to identify those clubs and districts that are part of the 501(c)(3) Group Exemption program is to go the CGCI website. Roll over “Club Services” then “501(c)(3) Group Exemption” and click on 501(c)(3) clubs.

For all Clubs who filed the IRS Form 990-N (Electronic Postcard) for the first time last year, filings were due 5 ½ months after the close of your last fiscal year. While there are no penalties for late filing, the second filing needs to be completed.

For those clubs who are incorporated, a reminder of the biennial filing with the California Secretary of State of the Statement of Information (Form SI-100).

Legislation/Government

At the 2009 Convention, in San Mateo, I reported that the Kyoto Protocol, regarding Green House Gasses, will be expiring at the end of 2012. A series of meetings has just concluded in Copenhagen, Denmark. The objective of the meetings, which brought together World Leaders, including President Obama, was to craft a new agreement to replace Kyoto. It was hoped that a framework for climate change mitigation beyond 2012 would be adopted.

Unfortunately, a large scale agreement was not reached. The Copenhagen Accord was drafted by the US, China, India, Brazil and South Africa. The agreement was “recognized” but not “agreed upon” in a debate of all participating countries and was not passed unanimously. The document recognized that climate change is one of the greatest challenges to the present and that actions should be taken to keep any temperature increases to below 20C. The document is not legally binding and does not contain any legally binding commitments for reducing CO2 emissions.

An interesting alternative viewpoint on climate change is advanced by John Coleman, cofounder of the Weather Channel and a trained meteorologist. At the 2009 Fall Board, in Concord, I reported on the state of State Parks. At that time, due to budget cuts, more than 100 parks were expected to be closed to the public. At this time it appears that no park facilities have been permanently closed but approximately 51% have had reductions in service, especially during mid-week days and during the winter season.

As a way of raising funding for park operation an Initiative has been approved for circulation. Over 433,971 signatures must be gathered by May 28 to be on the November 2010 ballot. If approved by voters, some 28 million California vehicles would be assessed an \$18 surcharge. Commercial vehicles would be exempted. An estimated \$500 million would be raised. Motorists would no longer be charged for day use of parks. Roughly 85% of the revenue would go to parks, 7% to the Dept. of Fish and Game, 4% to the Ocean Protection Council, 2% to the Wildlife Conservation Board and 2% to state conservancies for managing state lands.
