The group of people who meet, referred to as the *deliberative assembly* (such as this board of directors), discuss issues and make decisions on behalf of the entire group. *Parliamentary procedure* is the set of rules that the group agrees to follow in the deliberation process. The terms parliamentary procedure and parliamentary law are frequently used interchangeably.”

As of August 25, 2014, Awards Finance has received \$490 which has been reconciled with the CGCI Treasurer.

### **Convention Chairman, Robin Pokorski**

The San Fernando Valley District was pleased to have you visit our interesting part of our Golden State. We welcomed nearly 300 from all over California. The final registration count was 284, comprised of 135 board members and club or APS presidents; 60 spouse and guests; and 88 San Fernando Valley District members. 220 room nights were used. The Awards Banquet continues to be the most popular banquet with 137 attending. 69 souls left for Forest Lawn; 69 souls were returned safe and sound to the Hilton.

For future consideration, the full-time or multiple day registration fee of \$35 might be cutting it very close. Approximately 60% of the total registration fees collected went to covering the cost of audio-visual expenses. This left little money available for speakers, printing, workshop materials, and everything else that needs to be covered. Don't be surprised if registration fees simply must be increased to cover costs and keep districts interested in hosting these conventions.

Overall, it was a wonderful experience for our district, this chairman would encourage every district (large AND small) to offer to host and bring us to your lovely part of California.

Revenue received totaled \$38,020.09 less expenses of \$32,220.81 for a net excess of \$5,799.28. Split 50-50 with CGCI, it is with great pleasure that I present a check in the amount of \$2,899.64 to President Rita with our district's heartfelt thanks for giving us the opportunity to host the convention as we found that Together We Grow!
