President Sue Bennett called the meeting to order at 4:08 p.m. on Monday, February 1, 2016
(Business Meeting #1).

Bylaws and Policy, Greg Pokorski reported for the committee and moved that the following bylaws amendments be recommended to the voting membership at the 2016 convention in May:

1) ARTICLE VII – BOARD OF DIRECTORS (page 87)

Now Reads:

Sec. 1. Composition of the board of directors shall be: (a) officers; (b) district directors; (c) members of the nominating committee; (d) members of the board of trustees; (e) members of the advisory council; (f) members of the bylaws committee; (g) members of the Circle of Poppies; (h) editor and members of the *Golden Gardens eNews* committee; and (i) all committee chairmen. One third shall constitute a quorum. No member shall be entitled to more than one vote.

Amend by inserting “All board members except members of the advisory council and the Circle of Poppies shall hold membership in a member garden club.” Immediately after statement (i).

To Read:

Sec. 1. Composition of the board of directors shall be: (a) officers; (b) district directors; (c) members of the nominating committee; (d) members of the board of trustees; (e) members of the advisory council; (f) members of the bylaws committee; (g) members of the Circle of Poppies; (h) editor and members of the *Golden Gardens eNews* committee; and (i) all committee chairmen. All board members except members of the advisory council and the Circle of Poppies shall hold membership in a member garden club. One third shall constitute a quorum. No member shall be entitled to more than one vote.

Rationale: Now only officers are required to belong to a member club. To best represent the interests of CGCI, board members should be members of member clubs. Exceptions: members of the advisory council and Circle of Poppies currently have lifetime board positions and are not always active board members and because of age or other reasons may at some point be unable to participate in a club, or have one geographically available to them.

2) ARTICLE XIII – GOLDEN GARDENS eNEWS (page 91)

Now Reads:

Sec. 4. Funds from advertising and donations shall be deposited in the general fund.

Amend by striking “advertising and”.

To Read:

Sec. 4. Funds from donations shall be deposited in the general fund.

Rationale: Advertising is not needed to fund the publication since it is delivered electronically. No advertising is being accepted.

Motion Passed

3) ARTICLE XIV – BOARD OF TRUSTEES (page 91)

Now Reads:

Sec. 1. The board of trustees shall consist of six (6) members, two of whom shall be replaced each even-numbered year, to serve for a six-year term. In the even-numbered year, the immediate past president shall be extended the option to become a member, and the president shall appoint a member who has served on the board of directors. Assumption of duties shall commence upon the close of convention. No trustee shall serve concurrently as an officer. A trustee may serve more than one term but terms shall not be consecutive.

Amend by changing length of service from six-year term to four-year term in first sentence and delete the last sentence regarding term limits in its entirety.

To Read:

Sec. 1. The board of trustees shall consist of six (6) members, two of whom shall be replaced each even-numbered year, to serve for a four-year term. In the even-numbered year, the immediate past president shall be extended the option to become a member, and the president shall appoint a member who has served on the board of directors. Assumption of duties shall commence upon the close of convention. No trustee shall serve concurrently as an officer.

Rationale: 1. Reducing the term from six to four years should make it easier to find qualified members to serve on the board of trustees (especially when it involves the immediate past president who has likely already served several years as vice president in addition to president). 2. In addition, as the duties of the board of trustees have become more complex in understanding CGCI's finances involving the endowment funds, various restricted funds and overall finances, it is better for the organization to keep qualified individuals with financial knowledge and willingness to serve on the board of trustees rather than limit their service that currently excludes serving consecutive terms.

4) ARTICLE XIX – AMENDMENTS (page 92)

Now Reads:

Sec. 2. Proposed amendments to the bylaws must be submitted to the bylaws committee chairman by November 1.

Amend by changing “November 1” to “one week before the Fall Board Meeting.”

To Read:

Sec. 2. Proposed amendments to the bylaws must be submitted to the bylaws committee chairman by one week before the Fall Board Meeting.

Rationale: The only opportunity the bylaws committee has to meet and discuss proposed changes to be presented to the board of directors at the Winter Board Meeting is at the Fall Board Meeting, prior to November 1.

Motion Defeated

On behalf of the Bylaws and Policy Committee, Greg Pokorski moved the amendment of the following standing rules, effective immediately:

5) SR32 (page 94)

Now Reads

32. Financial statements of treasurer and financial secretary shall be attached to the minutes of the board of directors meetings.

Amend by deleting and replacing with new SR32.

To Read:

32. The full balance sheet and income statement of the treasurer, as presented at each meeting of the board of directors, shall be attached to the minutes.

Rationale: To clarify the exact financial statement to be provided and to improve transparency by posting the information where it is more visible to board members.

Motion Passed as Amended

6) SR41 (page 94)

Now Reads

41. A copy of the audit/review shall be given to the president, first vice president/president elect, treasurer, financial secretary, *Golden Gardens eNews* editor and finance chairman. A copy will be provided to a board member upon written request and receipt of the cost of reproduction and mailing.

Amend by deleting and replacing with new SR41.

To Read:

41. A copy of the CPA's annual reviewed financial statements shall be given to members of the executive committee, board of trustees and budget & finance committee. A copy will be provided to board members upon written request and receipt of the cost of the reproduction and mailing.

Rationale: The term "audit" currently in SR41 is incorrect as it denotes more detailed analysis of every deposit and expense than what actually takes place. As described in the August 29, 2014 Independent Accountant's Review Report from Carolyn Mayes, CPA: "A review includes primarily applying analytical procedures to management's financial data and making inquiries of organization management. A review is substantially less in scope than an audit, the objective of which is the expression of an opinion regarding the financial statements as a whole." Clarify who is actually receiving copies of the reviewed financial statement.

Motion Passed

7) SR73 (page 95)

Now Reads

73. Affiliates shall (1) be organizations with one or more CGCI objectives, (2) have a membership of at least ten members, (3) pay dues in accordance with Article IV, Sec. 3(c), (4) be approved by the board of directors, and (5) not be eligible for liability insurance, awards program and CGCI Group Tax Exemption Program. In addition, affiliates may also belong to a district.

Amend by inserting “and/or Directors & Officers insurance” in (5) after “liability insurance.”

To Read:

73. Affiliates shall (1) be organizations with one or more CGCI objectives, (2) have a membership of at least ten members, (3) pay dues in accordance with Article IV, Sec. 3(c), (4) be approved by the board of directors, and (5) not be eligible for liability insurance and/or Directors & Officers insurance, awards program and CGCI Group Tax Exemption Program. In addition, affiliates may also belong to a district.

Rationale: Clarifies that liability insurance and/or D&O liability insurance is strictly a benefit of membership for clubs & APSs who pay per capita dues, not for affiliates who remit a flat fee regardless of the number of members.

Motion Passed

On behalf of the Bylaws and Policy Committee, Greg Pokorski moved that the following bylaws amendment be recommended to the voting membership at the 2016 convention in May:

8) ARTICLE XII - FINANCES (page 90)

Sec. 10. Accounts of the financial secretary and treasurer shall be audited/reviewed annually at close of fiscal year by a certified public accountant approved by the board of directors. This audit/review report shall be presented for action at the fall board meeting. A special audit/review shall be ordered by executive committee in the event of a vacancy in a financial office.

Amend by deleting “audited/” after “treasurer shall be”, by deleting “audit/” after “This,” deleting “audit/” after “A special”, and replacing “shall” with “may” before “be ordered by executive committee.”

To Read:

Sec. 10. Accounts of the financial secretary and treasurer shall be reviewed annually at close of fiscal year by a certified public accountant approved by the board of directors. This Review Report shall be presented for action at the fall board meeting. A special review may be ordered by executive committee in the event of a vacancy in a financial office.

Rationale: To be consistent with change to SR 41.

Motion Passed as Amended

On behalf of the Bylaws and Policy Committee, Greg Pokorski moved the amendment of the following standing rules, effective immediately:

9) SR40 (page 94)

40. The accountant's annual audit/review letter shall be published in *Golden Gardens eNews* following the fall board meeting.

Amend by deleting “audit/” after “accountant’s annual”.

To Read:

40. The accountant's annual Review Letter shall be published in *Golden Gardens eNews* following the fall board meeting.

Rationale: To be consistent with change to SR 41.

Officers' Reports

Parliamentarian, Greg Pokorski

In addition to the usual activities since our last meeting of working with the Recording Secretary to review minutes and assisting the President in preparation for this meeting, this officer assisted 1st Vice President Krystal Migliore for several weeks as interim chairman of the Bylaws & Policy Committee and had ongoing interaction with the Nominating Committee.

Unfortunately, Sherry Molinari resigned from the board and as chairman of the Nominating Committee. Because each district gets the opportunity to be represented on the Nominating Committee on a rotational basis, the bylaws require any vacancy to be filled from the district of the person who resigned. We have been unable to secure a replacement from the limited number of current and recent board members from Channel Islands District – so the Nominating Committee will move forward with six instead of seven members until such time that Channel Islands District might be able to offer a replacement. They can operate with a quorum of five, and Carole Lung has been elected the new chairman. She is not present at this meeting where Rosa Radicchi has facilitated the committee's meetings.

Life happens and alters our plans, but this does remind us that the Nominating Committee has a critical role to fill. It is not too early for all districts other than those currently serving to think about who might represent their district in the 2017-2019 term. That committee will be elected at the 2017 convention. Potential candidates need to be able to attend all CGCI meetings – and they will be members of the board whether or not they hold other positions.

Help and support the current Nominating Committee. Let them know if you are interested in serving as an officer or if you know of someone who should be considered for an officer position. Myrtle Findley, a member of the Nominating Committee, said today in the Chairmen's Meeting that we should not join organizations to sit in a chair – we should join to someday be president.

Remember that we have roll call to establish a quorum to make sure that decisions governing the organization are not made by a very small number of members. Please attend all business meetings and encourage other board members to do so as well. I know I'm preaching to the choir, but if we don't show up here we are not fulfilling our obligations to the organizations. If District Directors do not show up, they are also not effectively representing their districts.

Convention will soon be here. All member clubs are entitled to representation by their president or an alternate and by delegates according to the size of the club.

When the Call to Convention goes out all clubs that are sending any representative to convention need to complete the credentials form that will go with the Call. If a person says they are a delegate on their registration form that does not make them a delegate. Their club must elect or appoint them to be delegates. Board members do not complete credential forms. You already have a vote. If you are a board member and a club president, you have one vote as a board member. Get someone else to represent your club as your alternate. If you are a board member you cannot serve as a delegate from your club. Get someone else to serve.

Directors, please be sure that all clubs attending convention complete a credentials form.

Committee Reports

Advisory Council, Rita Desilets

Board of Trustees, Julie West

The Board of Trustees (BOT) met with Bob Gordon, Endowment Funds Promotion Chairman and established \$2,000 as the 2015-2017 fundraising goal for the CGCI and Scholarship endowments.

The BOT also met with Martha Smyser, CGCI Scholarship chairman, who distributed 8 scholarship applications electronically prior to winter board. The \$2,000 Robert L. Mason Bee Issues to Deal With Now

If you purchased a drilled block of wood for a bee home, it is recommended that you not use them as it is practically impossible to harvest your bees and this is the only way to separate pests from cocoons.

Pollen mites and other pests thrive in the holes and over the years you wind up with a block of wood with no mason bee cocoons. Think of your bees now and give them a good home this spring. Your bees will thank you with increasing population and pollination in years to come.

Blue Star Marker, George Unrine

It has been two years since last price increase. Increase is likely in May. NGC added a Gold Star Marker to honor Gold Star families. Details in the Winter/2016 issue of National Gardener. There is no highway version and an NGC club must sponsor the marker whether or not they purchase, install and dedicate the marker. This Chairman encourages clubs to say yes if asked for support by non-NGC organization. New **Browallia Endless Illumination** (lavender blue) and **Endless Flirtation** (white), both good in containers, Zone 10-11, deep shade to part shade, and blooms spring-summer. The 17 trees saved by recycling one ton of paper can absorb a total of 250 pounds of carbon dioxide out of the air each year. Recycling is not about all or nothing. Every little bit counts!
