2019-2020 LIABILITY INSURANCE

Dear CGCI Club and Associate Plant Society Treasurers,

The General Liability Insurance for 2019 - 2020 will be \$1.50 PER MEMBER (with a minimum cost of \$20.00) per club. Please fill out the form in its entirety at the bottom of this sheet with your payment AS SOON AS POSSIBLE and before January 15, 2019 so the applications can be processed without a late fee.

Coverage for your club or society starts February 15, 2019 and extends through February 15, 2020. Certificates of insurance will be mailed to club treasurers by March 1, 2019. All copies of Additional Insured Certificates will be e-mailed to the treasurer.

*NOTE: NEW LIABILITY INSURANCE CHAIRMAN effective 4-15-2019 is Robin Pokorski - see contact info at top right. Robin will handle your insurance requests, certificates, etc. through 6-30-2021 including renewals. Don't forget late processing fee of \$15.00 for all certificate requests sent to chairman less than 14 days from date of event.

CGCI's Liability Insurance coverage with the Nonprofits Insurance Alliance of California includes a per occurrence limit of \$1,000,000 and a \$2,000,000 aggregate limit shared by all the insured groups (payment is based after all commercial and personal policies are exhausted.)

CGCI offers Liability Insurance as a benefit for those qualifying Clubs and Associate Plant Societies that have paid their CGCI membership dues. Affiliates are not eligible. If your CGCI dues have not been paid, send \$2.75 per member to Membership Administration Assistant - see the website for membership forms and instructions. Insurance coverage is not in effect if CGCI membership dues are delinquent.

\$1.50 FOR EACH MEMBER OF YOUR CLUB or \$20.00 MINIMUM FEE.

All policies will be effective February 15, 2019 to February 15, 2020. Make checks payable to CGCI. Mail to:

Moneys received after January 15, 2019 will have a \$25.00 late fee accessed for manual processing and handling except for new clubs.
