Q & A - NGC Schools News

Q: I am the President of the Garden Club Federation of XYZ and this question arises many times. How many refreshers must you attend in Garden Studies, Landscape Design and Environment Studies to obtain your master status in each.

A: It's Gardening (not Garden) Study (not Studies) School - a pet peeve of mine because so many get it wrong. And it is Environmental (not Environment).

Your question is not new, but it is still disconcerting that many people/Consultants apparently do not know this. **The answer is the same for all three schools** - and has been the same answer for many years: **After becoming a Consultant, one must complete four refreshers in order to become a Master Consultant.**

This information is contained in the NGC Handbooks for all three schools, has been publicized a number of times in *The National Gardener*, is available from NGC Schools Committees chairmen, and should be available from State Schools Chairmen. There are at least a couple references to this requirement on the NGC website: LD Form 15 (Mini-Guide for Students and Consultants) and Page 2 of Multiple Refresher Form 1-11. GSS Form 05-21 (Guide for Students and Consultants, the counterpart to LD Form 15) also indicates the requirement to complete four refreshers. These forms are part of the NGC Handbooks. All State Chairmen and anyone chairing a school should have the appropriate Handbook, available from NGC Member Services.

All State Schools Chairmen who are involved in conducting schools or refreshers should be in touch with NGC Accrediting Chairmen who have and share the correct information. I (and other Schools Committees members) encourage that the mini-guides be given to all students at every course - especially at Course I (when there are typically many new students) and at Course IV (when typically many students are becoming Consultants) and to all refreshing Consultants at any school or refresher event.

USGS: "Climate Change Projections for California's Bay Delta System: Five Things Resource Managers Should Know"

Bay Delta system provides:

1. Essential habitat for aquatic species, including Pacific salmon, steelhead trout, and delta smelt.
2. Irrigation water to millions of acres of farmland that produce crops valued at \$36 billion a year.
3. Water to 25 million people.

Five conclusions:

1. There is uncertainty about how the Bay Delta System will evolve in the future (flexibility and adaptability will be necessary for effective adaption strategies).
2. Today's extremes could become tomorrow's norms.
3. It's not just climate change (it's also land-use change).
4. Biological community changes are inevitable.
5. The challenge of meeting California's water demand will intensify.

News from Gardening Study Schools Chairman

Since Fall Board Meeting: Golden Foothills District completed Gardening Study School (GSS) Series 21 in Loomis/Citrus Heights with Course IV in late September. Ten students tested. Eight have completed the series and graduated from Provisional Consultants to become full-fledged Consultants. One Consultant refreshed.

Dos Valles Garden Club in Palomar District presented an excellent Bi-Refresher (GSS and Landscape Design) in late October. Twenty-two, including this chairman, attended. Seven Gardening Consultants refreshed.

Sadly, another 12 Consultants lapsed (despite many reminders and a number of opportunities to refresh) as of 12/31/11 and will be removed from the next CGCI Yearbook. Southern California Garden Club, my club, is sponsoring Series 22. Course I is July 2 & 3, 2012. Course II will be held August 30 & 31, 2012. Course III will take place January 30 & 31, 2013, and the Series will conclude with Course IV on March 28 & 29, 2013.

A full day of schools meetings took place at the National Garden Clubs Fall Board Meeting in late September. Several resulting changes in the schools programs have been reported in *The National Gardener* and *Keeping in Touch*. Changing Environmental Interns to Provisional Consultants was an idea born at one of our California Council meetings. The NGC committees are exploring the possibility of a new text for GSS.

As NGC GSS Chairman, this Chairman keeps busy writing for *The National Gardener* and *Keeping in Touch* and encourages all to read and share these articles.

Message from [Greg Pokorski](#), CGCI & NGC GSS Chairman

Greetings Gardening Consultants,

Remember that you (and Consultants from all NGC Schools) must refresh your certificates at least once every five calendar years in order to avoid a lapse in status. We have ten more Gardening Consultants who will lapse if they do not refresh (or request and receive an extension) by 12/31/2012. Most of these became Consultants at the Santa Rosa school which was completed in 2007 and have never attended a refresher event.

We do have more schools on the horizon - and Consultants may refresh for credit by attending one Course of a School. See information in this newsletter about Series 22 in Encino - with courses being held in July and August. We now have tentative dates for another school to be held in Eureka beginning in October (and continuing next January, April and July). Gardening Study students who are missing one or more classes needed to complete your studies are welcome to use these opportunities to complete your courses. Are you reading your garden club publications? There is an article on Gardening Study Schools in the current (Spring 2012) issue of *Golden Gardens* (pages 18-19). *The National Gardener* has long featured the *Landscape Design Angle* related to Landscape Design School and published news about the other schools from time to time. However, over the last three years there has been a concerted effort to include news about all schools in every issue. There is also news about Gardening Study and other schools in most issues of NGC's *Keeping in Touch*. Club presidents receive that publication by email. Is your president sharing the information with your club? If not, ask.

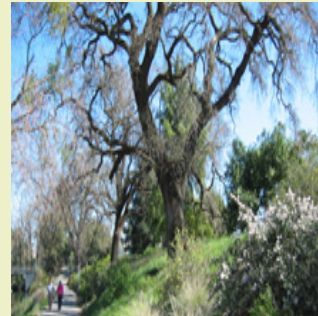

Conservation of Rare Native Plants in Your Landscape

Several of California's best known native plants have a restricted range and are threatened or endangered in their native habitat. In the past these native plants were abundant; but, due to urban growth, agricultural development and other impacts, many natural plant communities have been eliminated or drastically altered. One of the most important reasons to landscape in our home gardens and communities using native plants is to repair some of the habitat loss and habitat alteration by developing landscape plantings that conserve threatened and endangered species. "Nativescaping" or "wildscaping" are terms sometimes used to describe the use of native plants in our home and commercial landscape plantings.

These forms of landscaping lessen the impacts of habitat loss by preserving and conserving as much of the indigenous plant community as possible. They also provide connectivity between our residential areas and natural areas that are near our property by helping to create corridors of native plants.



Three native plants that are part of our natural heritage and that have been subject to near extirpation (defined as local extinction) in some places include Nevin's barberry (*Mahonia nevinii* - sometimes also listed as *Berberis nevinii*), toyon (*Heteromeles arbutifolia*) and bush anemone (*Carpenteria californica*). [Nevin's Barberry](#) (see photo by Chris Wagner, San Bernardino National Forest) is a rare endemic plant that is now federally listed as an endangered species. It has been practically eliminated from most of its original natural range. However, due to the ability of California propagators, many crosses and cultivars of native

barberry species have been developed. Nevin's Barberry is an adaptable shrub that does well in most California gardens. It can be planted as a specimen plant or used as a barrier or security plant because of its prickly holly shaped leaves. It has prolific fragrant yellow flowers in spring with red berrylike fruits that develop later in the season. It provides excellent songbird habitat.

Hollywood was known and named for toyons. The toyon was once abundant in the hills of Southern California. It bears a resemblance to European holly. It is adaptable, easy to grow, and is a beautiful shrub and wildlife habitat plant for the garden.

Bush anemone is a very showy flowering evergreen shrub with slightly fragrant camellia-like white flowers with yellow centers. Despite losing much of its native territory, it has a long history of cultivation. It was grown in England as early as 1880.

Arboretums, nature centers, botanical gardens and native plant societies often sponsor seasonal native plant sales where rare but wonderful natives can be purchased to plant in your garden. Look for these specialized sales. Wholesale growers, such as [Las Pilitas Nursery](#) and [El Nativo Growers](#), now propagate natives in large quantities to meet the growing demand for home and commercial landscaping. Check their websites. The three natives listed above can be found among plants being offered for sale on wholesalers' availability lists. Perhaps your garden club will obtain a re-sale certificate or seller's permit from the California Board of Equalization, or work with another organization that has a seller's permit, so that you can sponsor a sale to make these rare native plants available for your local gardens and communities. Help conserve our natural heritage. Celebrate a rare plant by planting it in your own garden.
