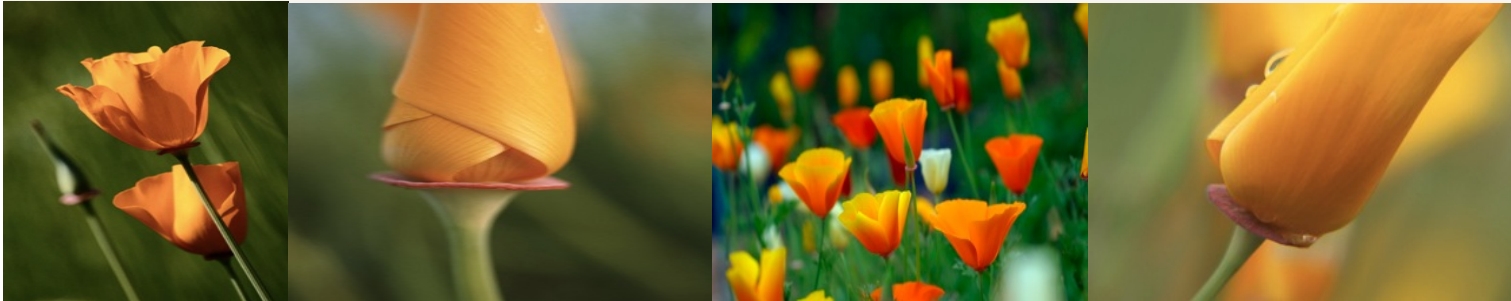

How to Protect Pots from Freezing

There are still some freezing nights to come [in some parts of California] and now is the time to protect your pots [if you haven't already done so]. Clay and concrete pots will withstand the cold winter months and freezing temperatures without cracking if they are sealed. Here's how to do this: Coat the inside walls and bottoms of your pots with paint-on roofing coating (be sure not to use the product called "roofing bull"). A good way to apply the coating is to use an inexpensive throw-away nylon paint brush.

Christmas Cactus Advice

Christmas cactus is a favorite houseplant often passed down from generation to generation as they are both long-lived and easy to grow. Modern hybridization has brought us many new varieties of Thanksgiving, Christmas and Easter cactus. Although called cacti, these plants (most of which come from Central and South America) are different in all aspects from the desert cactus which we all know. In their native habitat, they are found in the same environment as orchids. You will see them growing in the forks of tree limbs in the decayed leaves found there. Bear in mind, they are tropical and their growth requirements are totally different than that of true cacti.



For Christmas cactus to bloom, it needs short days and cool nights. Bright light, high humidity and slight moist soil are also essential. Fill a saucer with gravel and place under your plant. Keeping the gravel half filled with water will raise the humidity. Do not locate near a door or window which will open and cause a draft. Keep your plants away from heating ducts and select a bright spot where temperatures drop to 55-65 degrees at night.

After the holiday season is past, Christmas cactus should be given a chance to rest for about a 30 day period. Place it in a cool room and provide only a limited amount of water. It may lose a few leaves during this time which is no cause for alarm.

The best time to pinch or shape the plant is when you see new growth beginning in March or April. Repotting can also be done during this time, however, remember the best flowers will come from a plant that is pot-bound.

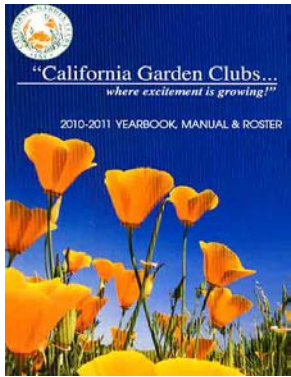
Do not over-fertilize to avoid getting only vegetative growth and no flowers. Apply 0-10-0 fertilizer in February. During the growing season (from April to September), fertilize plants with an all-purpose liquid houseplant fertilizer. Make sure to use one with a nitrogen content no higher than 10%.

For next year's blooms, leave your cactus outdoors during the summer months in a place protected from strong mid-day sun. Beware of snails; snails love these plants! Leave your plant there as long as possible and until the first frosts are predicted.

Professional growers keep their plants in a cool greenhouse with temperatures in the 50s and give them complete darkness for 12-14 hours per day with minimal watering. To give your plant total darkness, place a dark trash bag over the plant for the required number of hours. Given the right care and location, you will be rewarded with lovely blooms for the holidays next year.

IRS Nonprofit Group Exemption Q&A

Q: Our club's mailing address has changed. Should we notify the IRS?

A: You have two options here. You can file IRS Form 8822, Change of Address. Once the form is on your computer screen, you can fill in the blanks and then print and mail. Or, when you file your annual 990-N form, enter the new address and the IRS will eventually recognize the change.

Q: Our club members do not know what our EIN is (or have never applied for one). What do we do?

A: The easiest way to find your EIN is to look at your bank statement or ask the bank where you have your checking account. If you have never had an EIN, the easiest way is to apply online. Go the [IRS website](#). You can also get the EIN by telephone, by fax or by mail.

Q: Our club has applied to the CGCI Nonprofit Group Exemption Program; it has been ratified by the CGCI Board of Directors; and has received the letter of acceptance. We contacted the IRS and it doesn't show us as a nonprofit. Why not and what do we tell our donors?

A: The IRS has directed that CGCI can only make one filing annually, reporting renewing clubs and newly recognized clubs since the last annual filing. However, in its group exemption letter, the IRS has granted to CGCI the authority to confer nonprofit status to its approved members between CGCI's

annual filings. And the clubs which are part of the Nonprofit Group Exemption Program are listed on the CGCI website.
