### Message from the President [Julie A. West](#)

After the conclusion of my "official visit" to Diablo Foothills District Meeting on October 31, five of us went on a mission triggered by CGCI's *The Diamond Years*. The goal was to see if there was a plaque commemorating CGCI's contribution to the Mt. Diablo State Park Interpretive Center. CGCI assisted in raising funds for constructing interpretive exhibits in the Summit Building of Mt. Diablo State Park between 1987 and 1993, raising over \$5,000. A beautiful diorama depicts mountain scenes including shrubs, trees, flora and fauna that inhabit Mt. Diablo. It was dedicated October 6, 1993 which concluded the project. The mission was a success, and California Garden Clubs is listed as one of six original donors. The exhibit itself was recently renovated and is outstanding -- "one to be proud of." So if you are ever in the area of Mt. Diablo State Park, take the time and drive up to the summit to see for yourself. The view is incredible! ## Project Mission Blue

Project Mission Blue is the project of CGCI and the [Golden Gate National Parks Conservancy](#) to increase lupine diversity by propagating and planting pathogen-resistant summer lupine and varied lupine. It is the hope to stabilize the Mission Blue Butterfly community during years of fungal outbreak and allow these populations to increase over the long term. Discovered in San Francisco in 1937, the mission blue was one of the first insects added to the federal endangered species list in 1976. Today, it fights for survival in remaining fragments of its native Bay Area grasslands.

### Facts About the Mission Blue Butterfly - Part 3 of 3

#### Saving the Mission Blue Butterfly & Beyond

Today the Golden Gate National Parks Conservancy has monitoring programs to learn more about the mission blue and lupine populations. It also does a variety of habitat restoration projects such as invasive plant removal and planting native grassland vegetation. Preserving mission blue habitat protects other members of the grassland ecosystem, like birds, mammals and wildflowers, as well.

Restoring grasslands also reduces wildfire fuel buildup and conserves an important source for clean air and carbon sequestration.

- **Stay on designated trails** to avoid harming mission blues in all of their life stages.
- **Don't pick the flowers.** The more nectar plants available to mission blues, the better.
- **Learn** what mission blues' host plants look like and avoid disturbing them.
- **Avoid** planting potentially invasive species in your backyard.
- **Volunteer** for habitat restoration activities or donate to the Golden Gate National Parks Conservancy through CGCI.

## CGCI 501(c)(3) Group Exemption News

CGCI advises that all group exemption clubs/districts had their most recent fiscal year-end at June 30, 2011. All clubs/districts are required to file

the federal tax report appropriate to their club/district (form 990-N (electronically filed), form 990, or form 990-EZ) by **November 15, 2011**.

Group exemption clubs are also automatically members of the California group exemption (new this year, and applicable for years ended June 30, 2011 and forward). Clubs/districts are required to file, as appropriate, form 199-N (new this year; electronically filed) or form 199. The due date is **November 15, 2011**. 501(c)(3) organizations are required to be registered with the Attorney General's Registry of Charitable Trusts, and the annual report, form RRF-1, for the year ended June 30, 2011, is due **November 15, 2011**. There are no penalties for late filing of form RRF-1.

If a club/district has failed to file its required IRS tax form for three consecutive years, starting with years that ended June 30, 2007, it may be subject to automatic revocation of its 501(c)(3) status by the IRS at any time. The IRS has issued guidelines for clubs/districts to regain 501(c)(3) status, but these guidelines forbid CGCI from reinstating the organization in the CGCI Group Exemption Program. Clubs/districts need to follow these IRS guidelines, which are available on the IRS website.

CGCI is not a licensed tax preparation firm and is unable to provide further information related to a particular club/district's facts and circumstances. A club or district may wish to consult local tax professionals to assist it with specific facts and circumstances.

## Shrubs/Trees

When landscaping with trees and shrubs, we must consider many questions before beginning. Evaluate your site, look up, look side to side, look all around. Do you want a small or large specimen that will stand out in your garden. Think before you plant. Consider your water needs. Group water thirsty trees and shrubs together and remember drought tolerant plants can withstand more sun. Water deeply but less frequently to promote deep root systems. Don't be like me. I absolutely get mesmerized in my garden with a water hose in my hand. It's my fault I drown so many plants.



We must all try to be good to our gardens and our environment. Consider California native plants. The salvia family can be so colorful. *Salvia greggii* and the red and white flower of salvia 'hot lips' is darling. California ceanothus and toyon can stand alone or make an excellent hedge. The choices are vast. Bring on the color - try a purple peppermint tree next to bright yellow coreopsis and then add a bright red canna to the mix. What a beautiful world in which we live.

## Natural Resources

Natural Resources are derived from the environment. Living examples are: forests and their products, animals, birds and their products, fish and marine organisms. Mineral fuels, coal and petroleum were a once living organism. Non-living resources include sunlight, land, water, air and mineral ores such as gold, iron, copper, silver, etc.

The management of natural resources is a science-based system. Theodore Roosevelt, early in the last century is quoted as saying "The conservation of natural resources is the fundamental problem. Unless we solve that problem, it will avail us little to solve all others." For most identified problems in the natural resource field there exists a number of possible solutions. The fact that all of the problems have not been addressed should be considered a social problem. Not solving some of these problems has and can cause social unrest.

What are some of these problems?

**Depletion of rain forests**  
**Depletion of fisheries**  
**Depletion of arable soils**  
**Depletion of clean water**  
**Depletion of clean air**

For those resources that are not renewable, such as coal, petroleum and minerals, we have the choice of conserving them and recycling those that can be recycled. For all other resources, we need to find ways to make it possible to keep them going. Sustainability is the catch phrase for this.

What is the key to success? Understanding about our natural world and a desire to be of help in solving these problems would be a good start. As an example, our own CGCI is now involved in a long-range program to keep the Mission Blue butterfly from going extinct. These efforts are based on the knowledge of scientists who have studied the problem and appear to have a workable solution. Many agencies, federal, state and county, will be participating. School children will also be taking part to help out by growing the lupine these butterflies depend on for their very survival. This project, to save this butterfly, is a commendable example of people working together to help stem the loss of biodiversity.

The study of the natural world, to say the least, is complex. Everything is tied together. To work on one area affects other areas. Nothing is left by itself. So what can an ordinary citizen do? Find an area that you like, learn about it, and then get involved. The Internet is a great source of information. Support peer reviewed science. Do what you can, such as recycle, use sustainable gardening practices and let your voice be heard.

Where does something like climate change fit in? Most would agree that climate change is directly tied to poor or misunderstood management of our natural resources. Examples close to home would include our unusual weather patterns, the effect climate change is having on California agriculture. It appears likely that our long-term water supply is also threatened.

# CGCI Chairmen: Got Blog?

Did you know that, as a CGCI Chairman, you can have your very own BLOG on the CGCI website?

A blog is part of a website which is supposed to be updated with new content from time to time. Blogs are usually maintained by an individual with regular entries of commentary, descriptions of events, etc.



Through your blog on the CGCI website, you can bring your chairman's message to over 21,000 members of CGCI and the public. What a wealth of information you will be sharing!

Here are the simple instructions from the CGCI website on creating blogs:

## How to create a blog:

- Log in to your account.
- Go to "your" user menu (the block on the bottom left with your name in it).
- Click on Create Content.
- Click on Blog entry.
- Type the title of your blog post in the Title field. (This will show up as your blog post title and become your blog post name (path)).
- Type in your category under the word tags (e.g., Rose Notes, Mary, Mary, etc.). This is the one thing that distinguishes you from the other bloggers.
- Do nothing with menu settings for blogs; you can skip this section.
- Create your blog message in the body area.
- Scroll down to the bottom of the page and hit the Save button.
- You do not need to change anything between the body and Save button.

# The New *Robert's Rules* is Here!

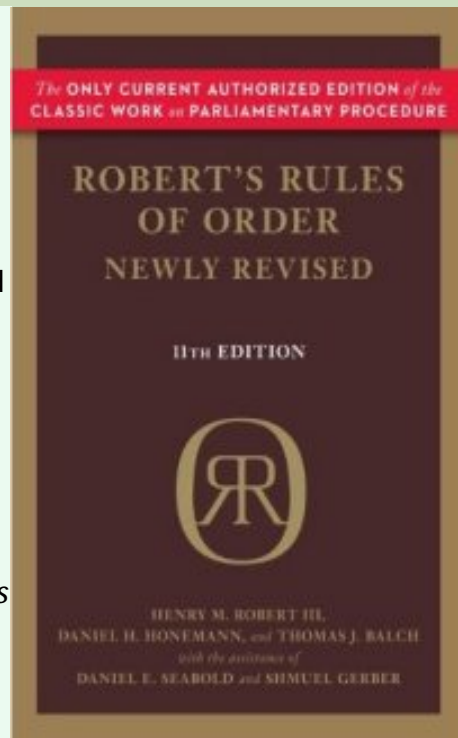

The current edition, entitled *Robert's Rules of Order, Newly Revised, 11th Edition*, was released in September. It supersedes all previous editions and is intended automatically to become the parliamentary authority in organizations whose bylaws prescribe *Robert's Rules of Order*, *Robert's Rules of Order Revised*, or *Robert's Rules of Order Newly Revised*.

CGCI's bylaws state (Article XVII), "The rules contained in the current edition of *Robert's Rules of Order Newly Revised* shall govern the corporation in all cases to which they are applicable and consistent with these bylaws and any special rules of order the corporation may adopt." CGCI does not need to amend its bylaws to begin using the new *Robert's* as its parliamentary authority. If your club or district has a similar provision it does not need an amendment to begin using the new *Robert's*. Since most bylaws do allow for this automatic switch to reliance upon the most current publication and since *Robert's* itself states that the new edition supersedes all previous editions, then it is important for all such organizations to quickly obtain and become familiar with the new edition. It is important for all members of an organization to use a single parliamentary guide. Older editions of *Robert's* have significant differences in their guidelines and page and section references, which can exacerbate disagreements instead of helping to settle them.

The 11th Edition, the first revision since 2000, is significantly re-edited with expanded and updated treatment of many topics. Its preface lists 17 significant changes and an additional 103 changes. Some key changes include: modified parliamentary rules in small boards and committees; electronic meetings and electronic communication; definition of a member "in good standing;" recognition of "Is there any debate?" as a less formal alternative to "Are you ready for the question?;" clarification of what rights members have to inspect records; and clarification of the relation between acts of an executive board and its parent assembly.

*Robert's Rules of Order Newly Revised In Brief* (for a simple and concise introductory guide) has also been published in a 2011 edition.

#### Corrections to Minutes

- Should be notated on minutes being corrected, initialed by secretary with date of correction.
- Corrections can be made at any time.
- If made after approval, will require a two-thirds (2/3) vote.



#### Common Errors in Minutes

1. Failure to include name of organization.
2. Failure to include the year of the meeting.
3. Failure to note who presided and who served as secretary.
4. Including the name of the seconder.
5. Including a detailed account of subsidiary motions to questions finally disposed of.
6. Failure to record points of order and appeals, with reasons for each ruling.
7. Failure to record motions adopted by unanimous consent.
8. Failure to record votes which should be recorded.
9. Including remarks from debate.
10. Recording excessive description of program.
11. Failure to record previous notice given at a meeting.
12. Omission of time and fact of adjournment.
13. Use of outdated closings, "Respectfully" and "Respectfully submitted."
